Summary of key findings

This provision meets requirements

- Staff understand the importance of meeting the needs of families in the wider community and how they can provide an inclusive service, where all children are welcome.
- Staff appreciate the benefit of supporting children to look after their own self-care needs. They create activities children can choose to complete independently, for example baking banana muffins.
- Staff routinely reflect on their practice and ensure they work towards continuous improvement. They understand the importance of keeping up to date with relevant training.
- There is a good focus on guiding children to be kind, respectful and to understand how their behaviour impacts on others. Staff encourage children to work well in a group, to share and to take turns.
- Staff provide healthy food and exercise choices. They offer a healthy snack of fruit and vegetables. They guide children to enjoy plenty of outdoors play, in all weathers, to support physical development on a daily basis.
- Staff know to speak in clear voices and hold engaging conversations. They understand the importance of encouraging children to express their thoughts and ideas, developing children's sense of uniqueness and showing them their opinions matter.
- Staff provide a stimulating environment, where children are able to grow in confidence.
- Staff understand how they can help children benefit from the opportunities available to them by encouraging their listening and attention skills and thus their participation in activities.
- Staff understand how building strong relationships with children and parents help develop a positive and respectful culture, as well as helping children feel safe and secure.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector spoke to children, to find out about their time at the setting.
- The inspector talked to staff at appropriate times during the inspection and took account of their views.
- Staff spoke with the inspector about the leadership and management of the setting.
- Parents shared their views of the setting with the inspector.
- The inspector looked at relevant documentation and reviewed evidence of the suitability of staff working in the provision.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
